





# **Certified Playground Safety Inspector Course**

2024/2025 Upcoming Inspector Certification Courses

November 6<sup>th</sup>-8<sup>th</sup>, 2024 – Element Event Center @ KOPFC January 27<sup>th</sup>-29<sup>th</sup>, 2025 – Utah Local Government Trust Building

**Registration:** All participants registered at least 10 days prior to CPSI Course will receive their textbooks before arriving at the course. All registrations received within 10 days of course start date will be given their materials the first day of instruction or they can be shipped their materials overnight at attendee's expense. (*Less than 10 days of precourse study can lead to exam failure.*)

### What Your Course Registration Covers:

- 15 hours of professional course instruction 1.5 CEU Credits
- CPSI Course Manual and Field Guide
- On-site Lunch and beverage breaks on instruction dates
- Inspector Certification Exam and 3-year certification for those who pass

**Certification Exam:** The certification exam will be given on November 8<sup>th</sup>, 2024 or on January 29<sup>th</sup>, 2025 depending on which class you register for. The certification is valid for three years and is renewable by exam. Those passing the exam will be added to a National Roster of Certified Playground Safety Inspectors.

**November Location – 5658 S Cougar Lane, Kearns Utah 84118:** The November training and exam will be held at the Element Center attached to the west side of the Kearns Oquirrh Park Fitness Center and East of the Olympic Oval. Enter through the doors east of the Olympic Oval.

January Location – 55 S HWY 89, North Salt Lake Utah 84054: The January training and exam will be held at the Utah Local Government Trust Building in North Salt Lake.
