**Registration:** All participants registered at least 10 days prior to CPSI Course will receive their textbooks before arriving at the course. All registrations received within 10 days of course start date will be given their materials the first day of instruction or they can be shipped their materials overnight at attendee’s expense. *(Less than 10 days of pre-course study can lead to exam failure.)*

**Certification Exam:** The certification exam will be given on November 8<sup>th</sup>, 2024. The certification is valid for three years and is renewable by exam. Those passing the exam will be added to a National Roster of Certified Playground Safety Inspectors.

**Location – 5658 S Cougar Lane, Kearns Utah 84118:** The training will be held at the Element Center attached to the west side of the Kearns Oquirrh Park Fitness Center and East of the Olympic Oval. Enter through the doors east of the Olympic Oval.
