Registration: Deadline **October 15th** or when Full. All participants registered at least 10 days prior to CPSI Course will receive their textbooks before arriving at the course. All registrations received within 10 days of course start date will be given their materials the first day of instruction or they can be shipped their materials overnight at attendee's expense. (Less than 10 days of pre-course study can lead to exam failure.)

What Your Course Registration Covers:

- ♦ 15 hours of professional course instruction 1.5 CEU Credits
- ♦ CPSI Course Manual and Field Guide
- On-site Lunch and beverage breaks on instruction dates
- Inspector Certification Exam and 3-year certification for those who pass

Certification Exam: The certification exam will be given on November 7th, 2025. The certification is valid for three years and is renewable by exam and/or CEU's. Those passing the exam will be added to a National Roster of Certified Playground Safety Inspectors.

NEW RENEWAL PROCESS: Beginning July 1st, 2026, there will be two potential ways to renew your certification either 1) sitting for and passing the CPSI Exam or 2) successfully completing 2.0 CEU's in playground safety during the 3-Year certification cycle and submitting a completed CEU Recertification Application. For those taking and passing this November 2025 CPSI Course & Exam you will qualify to recertify in 2028 by meeting the CEU requirements or by taking the exam again.
